Dear Participants and Parents:

Trip Information

General: Students will cycle Salt Spring Island and camp at Ruckle Provincial Park. Students will be responsible for obtaining a bike in good repair with appropriate safety equipment. They must also supply individual and group camping equipment (the school has a limited supply) as well as their meals. Cycling and camping instruction will be given prior to the trip.

Cost: \$ 55.00 Covers ferry and camping fees

Supervision: There are supervisors with cycling and first aid experience.

Risk Assessment:

Activity	Cycling a well travelled main road around the island and camping at Ruckle Provincial Park
Location	Southern part of Salt Spring Island
Camping	Provincial Park in tents; students are responsible for cooking their own meals.
Fitness Requirement	Distance covered each day will be between 20-40 km with a variety of hills and flats. Cardio and muscle fitness is usually less of a factor than saddle pain – a few rides on a bike will quickly eliminate this pain.
Weather	Students need to be prepared for all weather conditions. Expect sun, rain, and wind. Temperatures can range from +5° to + 25°C
Medical Problems	Abrasions in the case of falls; sore muscles

Special Equipment: Students must get their own bicycles either by borrowing from someone or renting. A cycling equipment list is available online at <http://dragonsoutdoors.weebly.com>

Behaviour: Due to nature of this trip, mature, responsible behavior is required at all times.
